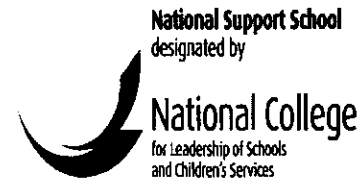
#### General

1. ### Loans and arrangements

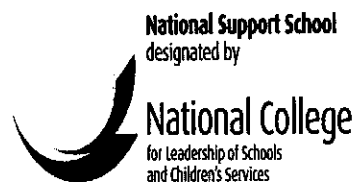
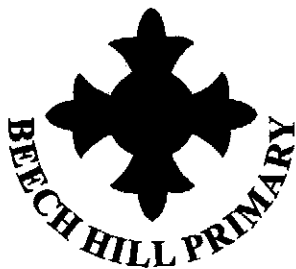
13. The academy trust has not granted any advances or credits to, or made guarantees on behalf of, directors other than those disclosed in the financial statements.

#### Grants and donations

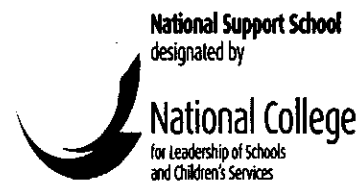
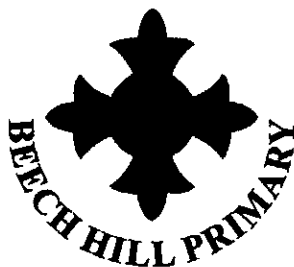

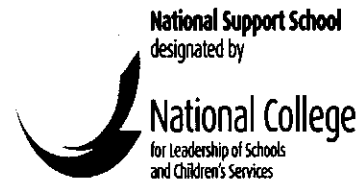
