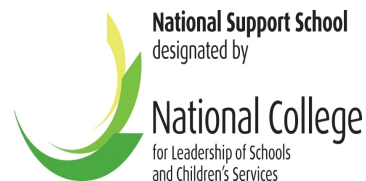
General

1.
