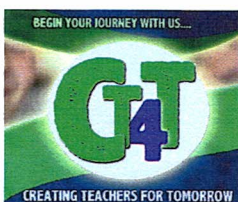

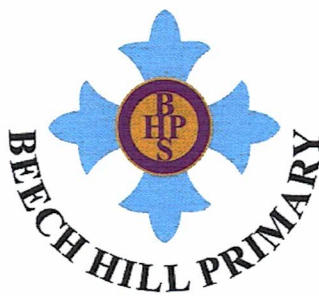
General

- 5 The effects of uncorrected misstatements are immaterial both individually and in total.

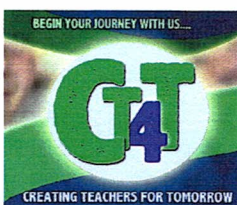
Internal control and fraud

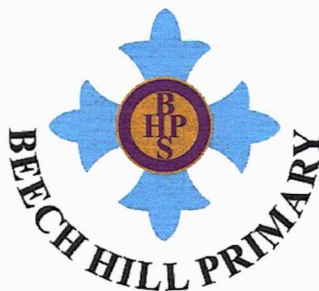
Assets and liabilities

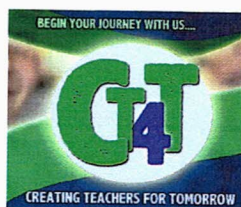
Law and regulations

- 17 All events subsequent to the date of the financial statements which require adjustment or disclosure have been properly accounted for and disclosed.

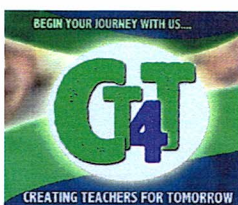
Going concern

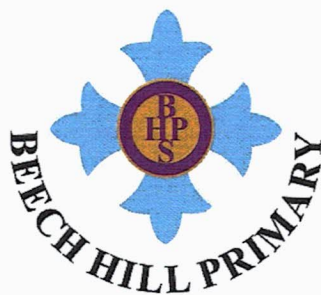
Grants and donations

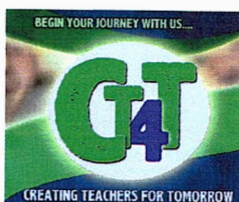
