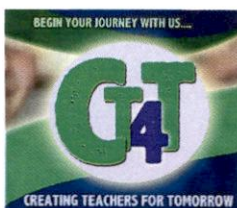

12 Significant assumptions used by us in making accounting estimates, including those measured at fair value, are reasonable.

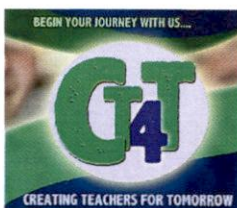
Loans and arrangements

Going concern

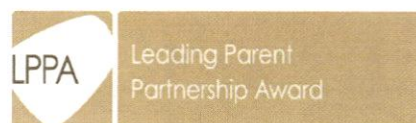
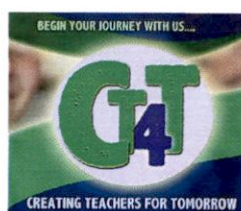

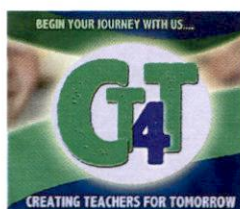
