2 All the transactions undertaken by the academy trust have been properly reflected and recorded in the accounting records.

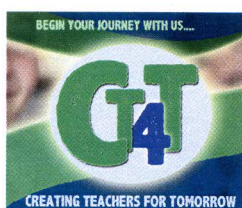

13 The academy trust has not granted any advances or credits to, or made guarantees on behalf of directors other than those disclosed in the financial statements.

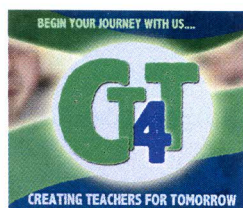

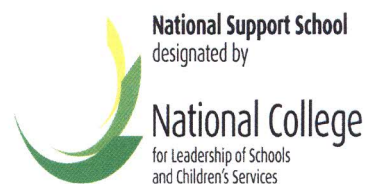

Grants and donations

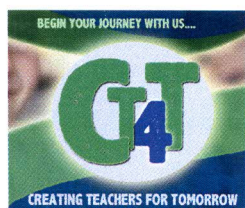
